5) Project Updates

a. Town Council Update: Chair Carey

There is a proposal for improvements at the high school campus for a lighted athletic field, new tennis courts, and a secondary entrance. The Board of Education has requested that the Town Council send the project out for referendum, the council will decide at their next meeting.

b. EV Charging Stations Report/ (Doolittle, MacPherson)

Mr. Doolittle gave a brief overview. The committee looked at 2 proposals and recommends the placement of the charger be over at the Town Library. Placement at the library would be more cost effective.

The idea is to choose an EV Charger and then use that same one at schools and other Town buildings/ facilities/ property.

The committee needs funding from the Town in order to cover the costs. Artisenergy would handle all of the administrative paperwork.

Chair Carey would first bring the item to the council as a discussion item. Hank made a motion for Jeff Doolittle to make a recommendation and present the findings to the Town Council at their next meeting. Michele seconded the motion, which was approved by unanimous voice vote. **MOTION CARRIES.**

c. Zoning Updates: (Wagner)

The EV Charger amendments will be effective as of January 23rd. The Capital Regional Council of Government (CRCOG) is currently reviewing the amendments. Mr. Wagner noted some of the revisions including; certain number of chargers and EV ready spaces. The Planning & Zoning Commission has suggested that only the conduit be provided, not including the wiring. The commission also reviewed handicap parking spaces.

B. Renewable Energy and Battery Storage Sub-Committee (Hank Cullinane)
Hank attended a DEEP hearing that revealed there is a lot of funding for EV Chargers. These are mostly available for smaller municipalities. The Town of South Windsor does not qualify for
