Proposed Regulated activities include construction of utility infrastructure to support the new bank and access drive through the site. 7,600 sq.ft. of disturbance within the upland review area is proposed, including the clearing to the DEP established development line, grading and installation of utility infrastructure. Erosion & sedimentation control measures will be implemented and vegetative cover established as soon as the permanent improvements are in place. Anticipated start of construction is Spring of 2022 and completion of the access drive and Bank near Fall of 2022. Minimal material is anticipated to be removed from site; import material is associated with pavement and building construction, and installation of utilities. The timeline of the remaining development not part of this application is unknown at this time.
