**CORRESPONDENCE AND REPORTS:** A copy of an article from the Connecticut Federation of Planning and Zoning Agencies Quarterly Newsletter entitled "A Wetland Buffer is Not a Setback" had been distributed to and briefly discussed by the Commission. The case study referenced in the article was *Farmer v. Conservation Commission*, 66 Conn. L. Rptr. 179 (2018).

The basis for the decision was that the inland wetlands agency does not regulate the upland review area. It regulates the activity within the upland review area that impact the wetlands.

**MINUTES:** 10/3/18

**CONSERVATION COMMISSION**: Jeff Folger stated that Bill Marshall and a group of volunteers from the Garden Club have been removing invasives from town owned property adjacent to the Town Hall. On Saturday, they will remove the remaining burning bush and start on the bittersweet. Folger is going to be there to put herbicide on the cut ends to help prevent the bittersweet from coming back.

**WETLAND OFFICER:** With the recent heavy rains, the Toll Brothers site did have some red water discharge from the site. Toll Brothers is working on e&s measures to prevent future issues.

## **NEW BUSINESS:**

**Appl. #18-55W – Town of South Windsor, Edwin Rd** – IWA/Conservation Commission application for construction of a stormwater outfall and associated utilities. The site is located westerly of Edwin Rd. Industrial (I) zone.

Town Engineer Jeff Doolittle and Project Engineer Bobb Grillo presented the application. The application is for the installation of a new outfall to handle the drainage from Edwin Road. There has been a drainage problem for several years in this area. The single catch basin will be replaced by a double catch basin. The existing underground pipe will be abandoned and a new 24 inch pipe will be installed to discharge to a different area on the site. The old pipe will be filled in and sealed off. It is believed the old pipe is deteriorated or damaged and leaking, which may be a cause of the drainage issue. There will be a small wetland disturbance at the interface of the watercourse and the slope. A drop manhole will be installed, along with riprap and a plunge pool. It is not feasible to try to repair the old metal pipe which is fifty years old. There are too many utility wires in the way to install the new pipe in the same area.
