- \circ Costs approximately within grant total; invoices come to Commission, turned over to town and is paid by the town, which in turn is reimbursed from the state
- \circ Commission consensus to hire company experienced in monument building for erection of The Wall
- $_{\odot}$ Excavation to begin this month, as soon as permit to dig is released
- Bricks will need some repair after completion, including those by plantings
