fire truck access. The amount of disturbance is 0.73 +/- acres (31,800 S.F.) of upland review  
area and would take approximately two months to construct and establish the proposed retention  
basin areas.

QUADRANGLE LOCATION

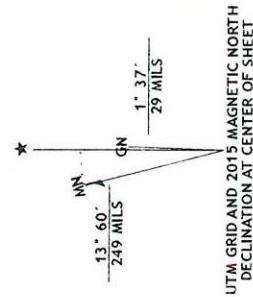

DECLINATION AT CENTER OF SHEET

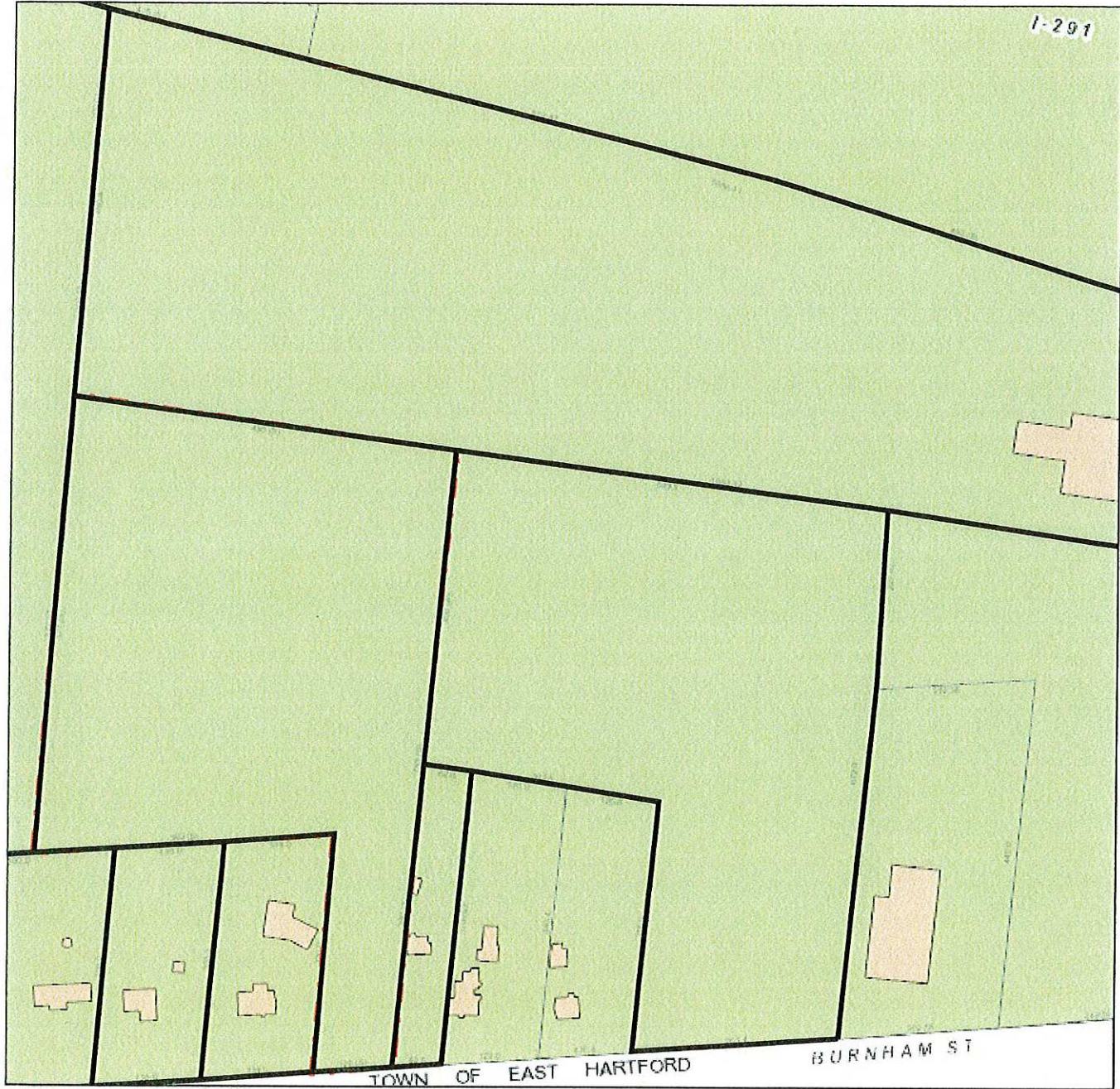
