Special Events + Special Event Parking

Dear Michelle,

This memo is in response to the Planning and Zoning Commission's request for information from the June 8th Public Hearing. Specifically, the Commission inquired as to the number and type of special events that would be anticipated at the new Pleasant Valley School, and the availability of special event parking.

SPECIAL EVENTS

I reached out to Pleasant Valley Elementary School Principal, Tiffany Caouette, and she was able to provide the following information regarding the special events at the school. They fall into three categories, and include:

Meet and Greet

Held annually as a morning event before the beginning of the school year. Approximately 500 attendees total, in three waves. All staff members are present. (127 staff).

170 +/- attendees per wave + 127 staff members = 297 total

297 total

Open House

Held annually as an evening event at the beginning of the school year. K-5 parents, approximately 70% attend, with virtual option about 50% of those attend virtually, and 50% attend in-person. All certified staff are in attendance. (55 certified staff).

700 k-5 families x 70% attendance = 490 virtual and in-person attendees (50% = 245 in-person / 245 virtual).

245 in-person families + 55 certified staff = 300 total

300 total

Evening Events

Held approximately once a month. 8-10 staff members, 6-8 PTO volunteers, 150 parents. Occasionally getting to about 250 attendees on rare occasions.

50 total (regularly) | **150 total** (occasionally) | **250 total** (rarely)



SPECIAL EVENT PARKING

Parking to support special events at the new Pleasant Valley School will be accommodated fully at the upper tier of the site closest to the new school building. The available parking is distributed as follows:

AREA 1

Parking within paved and lined parking spaces. 180 spaces

AREA 2

Parking spaces at curbside. 56 spaces

AREA 3

Parking on upper tier school grass playfield. 71 spaces

AREA 4

Parking within adjacent church parking lot. (MOU in process with church). 161 spaces

TOTAL SPECIAL EVENT PARKING

AREAS 1, 2, 3 = **307 Spaces** AREAS 1, 2, 3, 4 = **468 Spaces**
