We are pleased to advise you that the Planning & Zoning Commission voted on April 12, 2106 to approve the above referenced application.

This approval is for a site plan modification and Department of Motor Vehicle Used Car Dealer's license for the wholesaling of vehicles on property located at 1429 John Fitch Boulevard, I zone, as shown on plans prepared by Design Professionals Inc. dated December 8, 2015. This approval is subject to the following conditions:

- 1. This approval is for a used car license for wholesale only of cars at 1429 John Fitch Boulevard.
- 2. This approval does not constitute approval of the sanitary sewer, which can only be granted by the Water Pollution Control Authority.
- 3. Pavement markings must be maintained in good condition throughout the site drives and parking areas.
- 4. All free standing signs and/or building signs require the issuance of a sign permit before they are erected.
- 5. No building permit will be issued until the final mylars have been filed in the Town Clerk's office.
- 6. A landscape bond in the amount of \$3000 is required and must be submitted prior to the issuance of a certificate of occupancy if work is not completed. All bonds must be in one of the forms described in the enclosed Bond Policy.
- 7. An as-built plan is required prior to issuance of a Certificate of Occupancy per Section 9.1.3 of the Zoning Regulations.
- 8. All plans used in the field by the developer must bear the stamp and authorized signature of the Town of South Windsor.
- 9. A maximum of 48 cars are permitted to be stored outside.
- 10. Hours of operation are 8 a.m. to 5 p.m. Monday through Friday and Saturday 8 a.m. to 12 p.m.
- 11. No 18 wheel vehicles are allowed to enter the site.

- 12. No retail sales are allowed from the site.
- 13. No vehicles are allowed to be stored in the front portion of the site.
- 14. No vehicles are permitted to be washed outdoors in the parking area.
- 15. A dumpster shall be located at the westerly end of the existing building and placed on a concrete pad and screened.
- 16. Curb stops shall be added along the southerly boundary in the graveled areas.

Black and white transparent mylar of Sheet V-1 with the above modifications, together with three blueprint copies of the entire set of plans with live signatures and raised seals must be submitted to this Commission to be stamped and signed. The letter of approval of this Commission must be reproduced on the mylar.
