

South Windsor Senior Advisory Council Meeting

January 9, 2024

A motion was made to accept the minutes of the December meeting (Stroh/Field).

Daria introduced Dr. Kate Carter, Superintendent of Schools, to inform the Council on proposed high school campus improvements that may be on a town referendum in March 2024. A question and answer session followed the presentation.

Staff Comments: Center updates: The New Year's Eve party went well. A good time was had by all and everyone enjoyed the food from Lena's. Breakfast sandwiches have developed a good following; 65 people attended last month. We are hoping more people will sign up for the pancake breakfast coming up at the end of the January. We are hoping to have credit cards up and running by March. Electricians have finished hooking up the new dishwasher. A work order now is in for a plumber to finish the rest of the installment.

Community Resource Information: Sgt. Ron Littell informed us the Police Department is planning an open house in spring. The Triad will be hosting a pasta dinner/bingo fundraiser, January 10th.

Economic Development Update: Daria introduced our new Council Liaison, Mayor Audrey Delnicki. She informed us that Whole Foods at Evergreen Walk will be "Breaking Bread" on January 17th. Solutions to make the crosswalk on Nevers Road near Collins Crossing more noticeable were discussed. Mayor Delnicki will check with the Police Chief to see if he has any ideas about how to control the speed on Nevers Road.

Old Business: Reading in the Schools will resume in the Spring with dates at Eli Terry and Pleasant Valley School.
