SANITARY SEWER FEES AND CHARGES ARE
ESTABLISHED AND APPROVED BY THE WPCA
ON AN ANNUAL BASIS.

#### Assessment of Benefits

Pursuant to Section 7-249 of the CGS, anytime the Town acquires or constructs a sewerage system or portion thereof, the WPCA may levy benefit assessments in recognition of the benefits conferred upon the property by the existence of an operating sewer line. Benefits to buildings constructed after the initial assessment may be assessed as if the building had existed at the time of the initial assessment.

#### Capacity Charge

Pursuant to Section 7-255 of the CGS the WPCA may establish charges for the use of a sewerage system. The capacity charge is a charge on new buildings to contribute a pro-rata share of the costs of the system capacity and facilities needed to provide service. The fee shall reflect the appropriate amount of the share for that connection to the assets in the utility system and shall be calculated based on equivalent dwelling units.

### **Connection Charge**

Pursuant to Section 7-255 of the CGS the WPCA may establish charges for connection with a sewerage system. The connection charge is a one time charge for a building to connect to the public sewer system.

#### Drain Layer Permit Fee

Pursuant to Section 5.1(C) of the South Windsor WPCA Rules and Regulations the South Windsor Town Council establishes permit fees.
