- Why Build Multi-Use Greenways? Implications for Connecticut and Beyond Tuesday, May 31^{st]}
 - Presented by R. Bruce Donald East Coast Greenway Alliance
 - The East Coast Greenway is an Urban Appalachian Trail of 3,000 miles connecting 15 states
 - CT DOT now views mobility in terms of people and not just the unrestricted movement of vehicles
 - Benefits include: health, connectivity, tourism, increase property values, environmental and economic impact, and return of investment [1:1]
