WARNING OF ELECTION AND REFERENDUM  
NOVEMBER 2, 2021 MUNICIPAL ELECTION**

The electors of the Town of South Windsor are hereby warned to meet at their respective polling places in said Town, Tuesday, November 2, 2021 for the following purposes to wit:

- 1) To cast their votes for Town Council, Board of Selectman, Town Clerk, Town Treasurer, Board of Education, Planning & Zoning Commission, and Constables.
- 2) By way of Referendum:

To vote "YES" or "NO" on the following question:

"Shall the resolution entitled "Resolution Authorizing the Sale of a Certain Parcel of Property Known as Lot 2 and Located at 725 Sullivan Avenue, South Windsor, to JP RE Holdings, LLC for the sum of Two Hundred Sixty-Five Thousand Dollars (\$265,000), adopted by the Town Council on July 19, 2021 be approved?"

The ballot label will read:

"Shall the resolution authorizing the sale of a certain parcel of property known as Lot 2 and located at 725 Sullivan Avenue, South Windsor to JP RE Holdings, LLC for Two Hundred Sixty-Five Thousand Dollars (\$265,000) be approved? YES/NO"

The full text of said resolution is on file and open to public inspection in the office of the Town Clerk.

The vote will be by voting tabulator. Those in favor of the resolution referred to in the question shall fill in the oval next to the word "YES" above such question. Those not in favor of the resolution referred to in the question shall fill in the oval next to the word "NO" above such question.

The referendum will be held under the authority of section 314 of the Town Charter as amended and Chapter 152 of the Connecticut State Statutes, as amended.

The polls will be open from 6:00 A.M. to 8:00 P.M. and electors will cast their votes at the following polling places in the districts specified:

District No 2 Eli Terry School, 569 Griffin Rd  
District No 3 South Windsor High School, 161 Nevers Rd  
District No 4 Philip R Smith School, 949 Avery St  
District No 5 Timothy Edwards Middle School, 100 Arnold Way

Absentee ballots shall be available as provided by law at the Town Clerk's office during normal business hours. Central Counting of absentee ballots will be held at the Town Hall at 1540 Sullivan Avenue.

Election Day Registration will be held from 6:00 A.M. to 8:00 P.M. in the Council Chambers at Town Hall at 1540 Sullivan Avenue.
