ORDINANCE ###

AMENDMENT TO ORDINANCE #157 AND THE CODE OF ORDINANCES CHAPTER 2, ARTICLE III, DIVISION 14, SECTION 2-422

CHAPTER 2, ARTICLE III, DIVISION 14, SECTION 2-422 SHALL BE AMENDED AND RESTATED AS FOLLOWS:

**Sec. 2-422. Fee structure.**

- (a) The inland-wetlands agency fee structure shall be established by the Town Council.
- (b) These fees, with the exception of the additional fee for significant activity account, do not include any fee surcharge statutorily assessed by the State of Connecticut.

~~The purpose of this division is to establish the fee structure for the processing of applications submitted to the inland-wetlands agency, and the nonpayment of those fees shall result in the tabling of applications.~~

Sec. 2-422. Fee structure.

(a) The inland-wetlands agency fee structure is established as follows:

Single-family residential parcel..	\$ 50.00
Site plans.....	200.00
Subdivision plans.....	300.00
Plus, per lot.....	50.00

Additional fee for significant activity .....	300.00
Map amendment (single-family residential lot).....	25.00
Map amendment (other than single-family residential lot)...	200.00
Minor modifications of permit ...	50.00

(b) These fees, with the exception of the additional fee for significant activity account, do not include a \$10.00 surcharge statutorily assessed by the state for the funding of the state's environmental review team.
