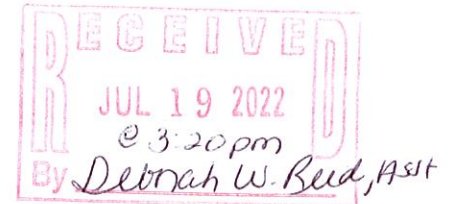


PUBLIC HEARING MINUTES
