PUBLIC HEARING MINUTES

South Windsor Town Council

PURPOSE: To Receive Citizen Input on the Appropriation of \$250,000 of LoCIP Funds to Cover Costs Associated with the Modernization of the South Winsor Public Library's Elevator

Deputy Mayor Paterna called the Public Hearing to order at 8:00 p.m.; and requested that the Clerk of the Council read the call of the meeting (a copy of which is attached hereto, **Exhibit A**). There were approximately nine (9) people present in the audience.

Councilor Snyder explained to the Council that the plan is to replace the mechanicals because these parts are no longer available, so it would be modernization of the elevator. If the Town were to replace the whole elevator, it would require the putting a new elevator car and shaft in.

Deputy Mayor Paterna asked if there was anyone from the public that would like to speak.

Mr. Roy Normen, 158 Homestead Drive came before the Council and stated that he was present to support the modernization of the South Windsor Public Library's elevator. Mr. Normen explained that he worked on a project at Wapping Community Church where the elevator was modernized at a substantially less cost then what is being proposed for this project. Mr. Normen said he would share the process they had to go through if anyone is interested.

Deputy Mayor Paterna requested that Mr. Normen send the Town Manager information.
