

PUBLIC HEARING MINUTES

South Windsor Town Council

**PURPOSE: To receive citizen input on an amendment to Ordinance
#132 – Chapter 86; Streets, Sidewalks and Other Public Places;
Article II., Section 86-31 through 86-80**
