#### PUBLIC HEARING MINUTES

September 19, 2016 8:00 p.m.

#### **South Windsor Town Council**

PURPOSE: To receive citizen input on the Appropriation of \$70,000 from the Capital Stabilization Fund to cover costs associated with the Construction of a Pavilion at Veterans' Memorial Park

Mayor Delnicki called the Public Hearing to order at 8:00 p.m.; and requested that the Clerk of the Council read the call of the meeting (a copy of which is attached hereto, **Exhibit A**). There were approximately twenty (20) people present in the audience.

Mr. John Caldwell, Superintendent of the Parks & Recreation Department came forward and explained that this is a pavilion which will be called Rotary Pavilion II and will be located at Veterans' Memorial Park on the top of the hill, on the back side of the park. The pavilion will overlook the parking lot and pool area. There will be a walkway from the existing concession stand so the pavilion can be accessed during non-pool hours but it will also have an entrance to the pool area. The Rotary Club raised approximately \$150,000 to \$200,000 and the plans have been put into place with the help of Design Professionals. The pavilion is the same type of pavilion that is at Nevers Road but will not have a kitchen area. This proposal is part of the Master Plan through the Park & Recreation Commission.

Mayor Delnicki asked if there was anyone from the public that would like to speak; there was none.

Mayor Delnicki asked for a Straw Vote, the results of which were as follows:

Those supporting the appropriation of \$70,000 from the Capital Stabilization Fund to cover costs associated with the construction of a pavilion at Veterans' Memorial Park: 12
