**PURPOSE: To receive citizen input on the Proposed General Government Budget for Fiscal Year 2019/2020**

Mayor Paterna also suggested that Mr. Handleman could also go onto the Town website because there are some previous businesses that are listed.


Mayor Paterna asked for a Straw Vote, the results of which were as follows:
