Deputy Mayor Paterna stated that Mr. Havens was first elected to the Council in 1971. Mr. Havens was also involved with other organizations such as the Channel 3 Kids Camp, past President and a member of the Board of Directors at the Channel 3 Kids Camp, co-founder and past President of the South Windsor Chamber of Commerce, received the Rotary Clubs highest award – the Paul Harris Award, received the Board of Education's Award for community service – the Eugene Policelli Award, selected Business Person of the Year by the Chamber of Commerce; and has donated to the Little League, Recreation Department, and the South Windsor Food and Fuel Bank without ever hesitating when it was needed.

Councilor Maneeley stated that Mr. Havens donated the necessary fund to hold the Annual Easter Egg Hunt which is something that a lot of children have enjoyed over the years.

Councilor Pendleton stated that Mr. Havens is a man of wisdom and fought to get the Town Hall Annex purchased for the Town. Thank you for your guidance on the Town Council and thank you for your hard work for this community.

Mr. Ed Havens came before the Town Council thanking them for this honor. Mr. Havens also thanked his family and the citizens of South Windsor for their support. The Council has been a part of his life for a long time, and he stated he loved every minute of it.

- Have met with residents who have concerns about putting lights at the High School stadium field. Mr. Galligan explained that process that would have to happen in order to have lights on the field which would be a time-consuming process.
- There has been a coyote problem in the Foster Street area of South Windsor. The public should take precautions to keep their animals safe. Even with fencing, their animals can be in danger. The Town is monitoring this situation.
- There are two ordinances that the Council will be reviewing. One is a Fracking Ordinance, and the other is a Construction Noise Ordinance.
- A roundtable under strategic planning will be held in January 2018 to talk about issues regarding Board and Commissions.
- The Council received a draft copy of the citizens' survey. Some of the questions are old and will be changed. If the Council would like to see any certain question on the survey, they should be emailed to Ashley.
- There is a website under CRCOG where individuals who feel they may have a crumbling foundation can go and apply for funds to test your foundation.
- There was a referendum process completed for the sale of a small piece or property at Evergreen Walk to the developer. The money generated from this small parcel is to be turned over to the State of Connecticut, Department of Transportation. It is the Town's wish that those funds remain with the Town of South Windsor for an economic development incentive.

Answering questions from the Council, Mr. Galligan explained that the Town is considering to do a citizen survey on-line. Mr. Galligan stated that South Windsor being put on the watch list by Moody's was not a result of anything that the previous Council had done. South Windsor was put on this list when it was being cut 6 million dollars in State funding during the budget process along with sixty other communities. The Town met with Moody's and is providing them with information to show them that the Town is financially stable and will be receiving a report from them shortly.

Answering further questions, Mr. Galligan explained that a strip of land at Evergreen Walk was not included in the prior deed removal. The strip of property is located on Buckland Road near LA Fitness. It is a road easement strip.

Mayor Anwar stated that he feels the roundtable discussion is a very good idea. There are some Commissions and Boards that are functioning in a very good manner, and there are others that need improvement. There may be an opportunity to have some Boards and Commissions have an equal number of members on them. This would eliminate members being bumped off when a different party is in the majority. Mayor Anwar then clarified that Rating Agencies look to how a town may respond to a negative situation that is created. The State budget will have impacts on communities and will especially have impacts on the Town's budget. The Town needs to strategize how to move forward in the future.

Answering further questions, Mr. Galligan explained that the Town had not done an educational session to the public regarding the coyotes. Coyotes follow their food source.

9. Communications from Liaisons, Officers, and Boards Directly Responsible to Council

Councilor Snyder reported that at the Planning & Zoning Commission meeting, a new 55+ development was approved called Evergreen Crossings which is behind Old Navy. This development will have 130 units consisting of four studio apartments, 61 one-bedroom apartments, 62 two-bedroom apartments, and four three-bedroom apartments. The development will be using all of the Town's public services. The estimated current property tax on this property is \$60,000. After construction is completed, the potential tax will be \$713,567 which represents an increase of \$653,000 of taxes annually.

Deputy Mayor Paterna reported that the Public Building Commission has been working on the plans and designs which are underway for the two new schools. This stage is overall design, and the next step will be detailed plans with the specific materials to be used, artistic renderings, etc. P.R. Smith will be demolished for construction of the new school, whereas Eli Terry students will stay on site while the new school is being constructed. The Superintendent hosted an open meeting with neighbors of both of those schools so they could share their concerns and ask any questions. Deputy Mayor Paterna stated he would be asking the Chairman of the Public Building Commission to come on a quarterly basis to report to the Council.

10. Reports from Standing Committee

Mrs. Athena Loukellis from the Energy Committee reported that the Energy Committee that the Town of South Windsor, in partnership with Eversource is promoting a program called Home Energy Solutions. This program will lower energy costs while improving energy efficiency. Residents pay \$149.00 to receive a complete energy assessment. The average household receives about \$1,000 worth of energy savings with a complete energy audit. In the past three months, there have been 97 residents take advantage of this program. The vendors are vetted through Eversource as well as the Energy Committee. The vendors that come to residential homes to do the audit have committed to donate \$25.00 to the South Windsor Food and Fuel Bank. The other item that Mrs. Loukellis stated she would like to report is that the Town of South Windsor has qualified for a \$10,000 grant which the Energy Committee would like to install lights on the Town Hall campus.

Galligan to further amend the Plan by adding seven (7) new positions to the "Job Classification and Fringe Benefit Description Plan for Non-Bargaining Unit Employees of the Town of South Windsor" for Fiscal Year 2016/2017 through 2018/2019, those of **Confidential Secretary** (Pay Grade 1), **Executive Assistant** (Pay Grade 2), **Senior Assessment Technician** (Pay Grade 2), **Assistant Superintendent of Streets** (Pay Grade 7), **Director of Human Services** (Pay Grade 10), **Assistant Town Manager/Director of Human Resources** (Pay Grade 12), and **Assistant town Manager/CIO/Emergency Management** (Pay Grade 12).

The Town Council had requested that a succession plan be established, and it was felt that the current employees could take on more responsibility which would free up the Town Manager to do more economic development. This proposal is more cost-effective than hiring additional employees.

Answering questions from the Council, Mr. Galligan explained that the first paragraph is eliminating positions. These positions are currently filled, but the titles will be changed. The position of the Director of Human Resources will remain an open position and would not be filled at this time. This

Mayor Anwar called for a vote on the motion; it was approved, unanimously.

H. Discussion Item: Sullivan Avenue/Buckland Road/Ellington Road/Oakland Road Intersection (Complete Streets) *(requested by Mayor Anwar)*

Mayor Anwar explained that he had requested that the Town Engineer send a written update on this item, as shown in attached **Exhibit B**. The idea of improving this intersection was to have the Town be a more walkable community. Individuals from the Town Hall or Library should be able to easily walk to the Town Center area. This is one of the busiest intersections and the proposed plan would create a more pedestrian friendly intersection. At this time, 90% of the work has been done and are looking at the spring of 2018 for things to move forward.

Answering questions, Mr. Galligan felt it would be helpful if a letter were drafted to South Windsor's Legislators getting them involved to help expedite this project.

Mayor Anwar asked the Council members for consensus to have a letter drafted and sent to the Town's Legislators; Councilors gave their consensus.

I. Discussion Item: Anti-Fracking Ordinance (requested by Mayor Anwar and Town Manager, Matthew B. Galligan)

Town Attorney Borea explained that he had received a request to take a look at the model ordinance that has been presented to a number of other municipalities in Connecticut. The Food and Water Watch is an organization that had originally drafted the model ordinance. After reviewing it and other ordinances from different municipalities, Attorney Borea stated that he drafted a new ordinance, as shown in attached **Exhibit C**.

Mayor Anwar stated that he feels it is worthwhile for the Town to have something in place for protection. At the next meeting, the Town Council will set a public hearing to establish an ordinance.

Councilor Pendleton requested that Town staff review this ordinance. Mr. Galligan stated he would have them review it and then send any changes to the Town Attorney to have him incorporate them into the ordinance.

Mayor Anwar asked for consensus to set a public hearing at the next Town Council meeting for this item. Councilor members gave consensus. Mayor Anwar also requested the Town Attorney to see if the Food and Water Watch Organization would be available to do a presentation at the January 16, 2018, Town Council Meeting.

J. Discussion Item: Construction Ordinance *(requested by Town Manager, Matthew B. Galligan)*

Mr. Galligan explained that he had town staff review the ordinance. The Police Department incorporated the penalties. This ordinance is an operational ordinance in the residential districts. If someone is in the industrial area and there are not a lot of residents around, the noise being disbursed may be allowed to continue, but in a residential district that is surrounded by houses, there will be limitations put on the hours. Mr. Galligan stated that he does not feel this ordinance is ready to move forward but should be reviewed further to make sure all of the necessary changes are in the ordinance. The Council can review the ordinance further at their next meeting before it is sent to public hearing.

Attorney Borea stated that he had incorporated the proposed changes that he received from the staff and the ordinance has been drafted as shown in attached **Exhibit D**. The penalty provisions have been revised with the proper statutory citations under enforcement. Attorney Borea informed the Council that they would have to review the hours when no work would be allowed. Attorney Borea stated that he put a provision called "plainly audible" into the ordinance. Plainly audible is a somewhat subjective

Standard that says if someone can clearly hear something from a certain distance, then that action is too loud. This ordinance is not just focused on noise, it limits the use of various equipment.

Mayor Anwar stated that the Town wants to have the construction done in a timely fashion, but at the same time, the Town does not want the neighbors to be negatively impacted. Mrs. Lipe had mentioned that during the summer months, the Town should extend the time to 6:00 p.m. rather than 5:00 p.m. The plainly audible provision may cause some enforcement issues and may be a little bit more aggressive than what the Town needs.

Town Attorney Borea stated that he had put the plainly audible provision in as an option. Attorney Borea reiterated that the ordinance limits the operation of certain equipment which means that the activity has been limited. The ordinance was drafted with flexibility in case the Town needs to give somebody relief. Changing of the summer hours makes sense.

Mayor Anwar requested that this ordinance exempt work on the inside of homes.

K. Discussion Item: Evaluating the Opportunity to Establish a Tax Fixing Agreement for Crumbling Foundations (*requested by Mayor Anwar*)

Mayor Anwar informed the Council and public that the State has some funds to start fixing homes with crumbling foundations. There are only limited funds which may address 5% to 10% of the needs so a lot of the homes may not get the funding and support necessary. At the previous Town Council meeting, Council members discussed the ability for the Town to give tax abatements to homeowners who reconstruct their foundations but have since found out that current legislation in the State of Connecticut does not allow the Town to do this. Mayor Anwar felt that it would be in the best interest of the Town to reach out to State Representatives to ask them to review and change State Legislation which would allow the Town to give incentives to homeowners who fix their foundations.

Councilor members discussed putting a limit on the amount of time someone could take advantage of this incentive. Town Attorney Borea explained that the problem would be that a homeowner only pays taxes on what their property is worth. If they don't fix the foundation, then they don't get the tax break after their foundation is fixed.



RE: Update on Sidewalks and Pedestrian Crossing Signal at
Ellington/Sullivan/Oakland/Buckland Intersection

The Town and our consultants have developed plans that are 90% complete to construct sidewalks along the east side of Sullivan Avenue and the west side of Buckland Road from the Town Library to Deming Street. These sidewalks will connect the Town buildings with the commercial businesses and residential units in the center of Town. The traffic signals at 3 intersections will be modified for pedestrian ramps, signals and crosswalks. Two small scale prints of the design for sidewalks and pedestrian crosswalks from the Town Library to the intersection of Ellington Road, Sullivan Avenue, Oakland Road, and Buckland Road are attached.

The Plum Gulley Brook Bridge on Buckland Road by Terry Office Park will be extended west to accommodate the new sidewalk. The Town has received approvals from the South Windsor Inland Wetlands Commission (in December 2016), CT DEEP (in July 2017) and from the ACOE (in November 2017) for the Plum Gulley Brook bridge extension.

We have received traffic signal permits from the CT DOT for the traffic signal modifications at the 2 intersections on Buckland Road at Deming Street and at Terry Office Park driveway. The plans for the signal modifications needed at the intersection of Buckland Rd, Sullivan Ave, Ellington Rd and Oakland Rd for pedestrian crosswalks are being done by the Town's Traffic Engineering Consultant and have taken longer than expected because CT DOT has reviewed these plans several times and have sent us several sets of comments to address. We are working to satisfy all the requirements of the CT DOT as it is a State owned signal and intersection and they need to approve the signal plans and issue an encroachment permit for this work.

We have reached out to 6 property owners along the sidewalk route and requested easements needed for the sidewalk.

Once we have received approval from ConnDOT and an encroachment permit for the traffic signal modifications and all the necessary easements the final bid package of plans and specifications for this project will be submitted to CRCOG and ConnDOT for final review and approval in the winter of 2017-18. The plan is to advertise this project for bids in the spring of 2018 for construction to start in the summer of 2018.

**TOWN OF SOUTH WINDSOR
ORDINANCE PROHIBITING NATURAL GAS WASTE AND OIL WASTE
FROM NATURAL GAS EXTRACTION ACTIVITIES OR OIL
EXTRACTION ACTIVITIES WITHIN THE TOWN**

Sec. 1. Purpose.

The purpose of this Ordinance is to protect, the health, safety, welfare and property of the residents of the town of South Windsor pursuant to the provisions of Section 7-148 of the Connecticut General Statutes by prohibiting the waste associated with drilling and extraction of natural gas and oil from being used for any purpose on any road or real property in the Town of South Windsor.

Sec. 2. Definitions.

For the purposes of this Ordinance, the following words, terms and phrases shall have the meanings respectively ascribed to them by this section, except where the context clearly indicates a different meaning:

- a) *"Application"* shall mean the physical act of placing or spreading natural gas waste or oil waste on any road or real property located within the Town of South Windsor.
- b) *"Hydraulic fracturing"* shall mean the fracturing of underground rock formations, including shale and non-shale formations, by man-made fluid-driven techniques for the purpose of stimulating oil, natural gas, or other subsurface hydrocarbon production.
- c) *"Natural gas extraction activities"* shall mean all geologic or geophysical activities related to the exploration for or extraction of natural gas, including, but not limited to, core and rotary drilling and hydraulic fracturing.
- d) *"Natural gas waste"* shall mean: 1) any liquid or solid waste or its constituents that is generated as a result of natural gas extraction activities, which may consist of water, brine, chemicals, naturally occurring radioactive materials, heavy metals, or other contaminants; 2) leachate from solid wastes associated with natural gas extraction activities; 3) any waste that is generated as a result of or in association with the underground storage of natural gas; 4) any waste that is generated as a result of or in association with liquefied petroleum gas well storage operations; and 5) any products or byproducts resulting from the treatment, processing, or modification of any of the above wastes.
- e) *"Oil extraction activities"* shall mean all geologic or geophysical activities related to the exploration for or extraction of oil, including, but not limited, to, core and rotary drilling and hydraulic fracturing.

f) "Oil waste" shall mean: 1) any liquid or solid waste or its constituents that is generated as a result of oil extraction activities, which may consist of water, brine, chemicals, naturally occurring radioactive materials, heavy metals, or other contaminants; 2) leachate from solid wastes associated with oil extraction activities; and 3) any products or byproducts resulting from the treatment, processing, or modification of any of the above wastes.

Sec. 3. Prohibitions.

a) The application of natural gas waste or oil waste, whether or not such waste has received Beneficial Use Determination or other approval for use by DEEP (Department of Energy & Environmental Protection) or any other regulatory body, on any road or real property located within the Town for any purpose is prohibited.

b) The introduction of natural gas waste or oil waste into any wastewater treatment facility within or operated by the Town is prohibited.

c) The introduction of natural gas waste or oil waste into any solid waste management facility within or operated by the Town is prohibited.

d) The storage, disposal, sale, acquisition, handling, transfer, treatment and/or processing of natural gas waste or oil waste from natural gas extraction activities or oil extraction activities is prohibited within the Town.

Sec. 4. Provision to be included in bids and contracts related to the construction or maintenance of publicly owned and/or maintained roads or real property within the Town.

a) All bids and contracts related to the retention of services to construct or maintain any publicly owned and/or maintained road or real property within the Town shall include a provision stating that no materials containing natural gas or oil waste shall be utilized in providing such a service.

b) All bids and contracts related to the purchase or acquisition of materials to be used to construct, or maintain any publicly owned and/or maintained road or real property within the Town shall include a provision stating that no materials containing natural gas or oil waste shall be provided to the Town.

c) The following statement, which shall be a sworn statement under penalty or perjury shall be included in all bids related to the purchase or acquisition of materials to be used to construct or maintain any publicly owned and/or maintained road or real property within the Town and all bids related to the retention of services to construct or maintain any publicly owned and/or maintained road or real property within the Town:

"We _____ hereby submit a bid for materials, equipment and/or labor for the Town. The bid is for bid documents titled _____. We hereby certify under penalty of perjury that no natural gas waste or oil waste will be used by the undersigned bidder or

any contractor, sub-contractor, agent or vendor agent in connection with the bid; nor will the undersigned bidder or any sub-contractor; agent or vendor agent thereof apply any natural gas waste or oil waste to any road or real property within the Town as a result of the submittal of this bid if selected."

Sec. 5. Penalties.

This ordinance shall apply to any and all actions occurring on or after the effective date of this ordinance. In response to a violation of this ordinance, the Town is empowered to:

- a) issue "Cease and Desist" orders demanding abatement of the violation;
- b) seek any appropriate legal relief, including immediate injunctive relief, as a result of any violation of this ordinance;
- c) file a complaint with any other property authority;
- d) require remediation of any damage done to any land, road building, aquifer, well, watercourse, air quality or other asset, be it public or private, within the Town, the Town may recoup from the offending person(s), jointly and severally, all costs, including experts, consultants and reasonable attorney's fees, that it incurs as a result of having to prosecute or remediate any infraction of this ordinance.
- e) Issue citations in the amount of \$250 per violation per day, or such other amount as is allowed by law, and seek any other remedies allowable under the law.

Sec. 6 Enforcement.

- a) The Town Manager, or a designee, is hereby empowered and authorized to, if appropriate, issue orders and other directives under this Ordinance and refer matters in connection therewith to the Town's Counsel.
- b) Town employees, officers and officials are not required to personally carry out testing of waste products to determine chemical contents, as this work may be done via contacting the State of Connecticut Department of Energy and Environmental Protection or the appropriate analytical laboratory or laboratories. If appropriate, the Town's Manager, or a designee, may request that the State of Connecticut, Department of Energy and Environmental Protection pursue civil penalties allowable under the law.
- c) A citation hearing procedure is hereby established pursuant to C.G.S. § 7-152(a). The Town Manager shall appoint one or more citation hearing officers, other than police officers or employees or persons who issue citations, to conduct the hearings authorized by this section. The citation hearing procedure provisions of C.G.S. § 7-152c, Subsections (c) through (g), inclusive, are hereby adopted by reference as if fully set forth herein.

Sec. 7. Severability.

If any clause, sentence, paragraph, subdivision, section or part of this Ordinance or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, effect or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this Ordinance or in its application to the person, individual, corporation, firm, partnership, entity or circumstance directly involved in the controversy in which such order or judgment shall be rendered. To further this end, the provisions of this Ordinance are hereby declared to be severable.

Sec. 8. Conflicts with other Ordinances or Codes.

In any case where a provision of this Ordinance is found to be in conflict with a provision of any other ordinance or code of the Town, the provision that establishes the higher standard for the protection of the health, safety, welfare and property of the residents of the Town shall prevail. In any case where a provision of this Ordinance is found to be in conflict with a provision of any other ordinance or code of the Town, which other ordinance or code establishes a lower standard for the protection of the health, safety, welfare and property of the residents of the Town, the provisions of this Ordinance shall be deemed to prevail, and such other ordinances or codes are hereby declared to be repealed to the extent that they may be found in conflict with this Ordinance.

Sec. 9 Transportation.

Nothing in this ordinance shall be interpreted to ban the transportation of any product or by-product described herein on any roadway or real property with the Town of South Windsor.

**THIS ORDINANCE WILL TAKE EFFECT IN ACCORDANCE
WITH THE TOWN CHARTER**

Construction Ordinance

§ 1-1. Legislative findings; purpose.

- A. Demolition and/or construction activity in Residential areas during early morning or late evening hours is a detriment to the public health, comfort, convenience, safety, welfare, peace and quiet of persons within the Town of South Windsor.
- B. The need for regulation of such demolition and/or construction activity is a matter of legislative determination and public policy, and this chapter is adopted in pursuance of and for the purpose of securing and promoting the public health, comfort, convenience, safety, welfare, peace and quiet of the Town of South Windsor and the people therein.
- D. Nothing in any portion of these regulations shall be construed in any manner as authorizing or legalizing the creation or maintenance of a nuisance. Compliance with these regulations is not a bar to a claim of a nuisance by any person. A violation of any portion of these regulations shall not be deemed to create a nuisance per se. This regulation shall not limit or supersede any specific zoning approval and/or condition of approval for any property.

§ 1-2. Definitions.

When used in this chapter, the terms below shall have the following meanings:

Construction: The assembly, erection, substantial repair, alteration, demolition, or site-preparation for public or private right-of-ways, buildings or structures, utilities or property.

Demolition: Any dismantling, intentional destruction or removal of structures, utilities, public or private right-of-way surfaces or similar property.

Holiday(s): New Year Day, Easter, Memorial Day, Labor Day, Christmas Day, and Thanksgiving Day.

Motor Vehicle: A vehicle as defined in the Connecticut General Statutes § 14-1(53), as amended, and Motorcycles as defined in the Connecticut General Statutes § 14-1 (54).

Person: Any individual, firm, partnership, association, syndicate, company, trust, corporation, municipality, agency, or political or administrative subdivision of the state or other legal entity of any kind.

Plainly audible: Any sound that can be detected by a person using his or her unaided hearing faculties. For example, but not limited to, if the sound source under investigation is a portable or personal vehicular sound amplification or reproduction device, the enforcement officer need not determine the title of a song, specific words, or the artist performing the song. The detection of the rhythmic base component of the music is sufficient to constitute a plainly audible sound.

Premises: Any building, structure, land, or other real property, including all parts thereof and appurtenances thereto owned or controlled by a person.

Property Line: The real or imaginary line along the ground surface and its vertical extension which separates real property owned or controlled by any person from contiguous real property owned or controlled by another person, and separates real property from public right-of-way.

Property Maintenance Equipment: All powered or manually operated tools and equipment used in the repair and upkeep of property, including, but not limited to, lawn mowers, riding tractors, wood chippers, power saws, and leaf blowers.

Public emergency sound signal: A device either stationary or mobile, producing audible signal associated with a set of circumstances involving actual or imminent danger to persons or damage to property, which demands immediate action.

Public facility maintenance: All activity related to the clearing, cleaning, repair and upkeep of public roads, sidewalks, sewers, water mains, utilities, and publicly owned property.

Residential District: Those areas that primarily consist of residential and multi-family dwellings so designated in the current Zoning Regulations and on the Zoning Map of the Town of South Windsor.

Sound: A transmission of energy through solid, liquid or gaseous media in the form of vibrations that constitute alterations in pressure or position of the particles in the medium and which, in air, evoke physiological sensations, including but not limited to, an auditory response when impinging on the ear.

§ 1-3. Standards.

A. Demolition and/or Construction Activity.

- 1) No person, firm, corporation or other entity shall operate or permit the operation of electric or fuel powered equipment, including but not limited to pile drivers, backhoes, pneumatic hammers, derricks, trucks of more than 10,000 pounds gross vehicle weight (GVW) on a construction site, and hoists required for construction, repair or demolition work between the hours of 5:00 p.m. and 7:00 A.M. Monday through Saturdays or at any time on Sundays and official state holidays.

B. Property Maintenance between the Hours of 9 p.m. and 7 a.m.

- 1) No person shall cause demolition, construction or maintenance noise that is plainly audible at a distance of 100 feet or more from the property line of the premises where said demolition, construction or maintenance work is being done, between the hours of 9 p.m. and 7 a.m.

§ 1-4. Exemptions.

The following shall be exempt from the provisions of this chapter:

- 1) Operation of domestic construction and property maintenance equipment between 7 a.m. and 9 p.m., except on Holidays.
- 2) Operation of engine-powered or motor-driven lawn care or maintenance equipment shall be exempted between the hours of 7:00 a.m. and 9:00 p.m. provided that exhausts are adequately muffled to prevent loud and/or explosive noises therefrom.
- 3) Operation of snow removal equipment at any time shall be exempted provided that such equipment shall be maintained in good repair so as to minimize noise, and noise discharged from exhausts shall be adequately muffled to prevent loud and/or explosive noises therefrom.
- 4) Operation of equipment of the Town or State constructing or maintaining public infrastructure.
- 5) Emergency work which is required for the protection or preservation of property or health, safety, life or limb of a person, including use of emergency or portable generators during periods of power outages.

1-5. Variance.

- A. Any person residing or doing business in the Town of South Windsor may apply to the Town Council or its designated representative for a variance for not more than one year from the provisions of this Chapter, provided that the applicant, at least forty-five (45) days prior to the date of said activity, provides the Town Manager with a written request for a variance to be acted on by the Town Council containing all of the following information:
 - 1) The location and nature of activity;
 - 2) The time period and hours of operation of said activity;
 - 3) The nature and intensity of the demolition and/or construction activity;
 - 4) Any other information required by the Town Manager.
- B. No variance from this Chapter shall be issued unless it has been demonstrated that:
 - 1) The proposed activity will not constitute a danger to the public health; and
 - 2) Compliance with this Chapter constitutes an unreasonable hardship on the applicant provided that such hardship is not the result of the applicant's own actions or inaction.
- C. The application for variance shall be reviewed and either approved or rejected at least five days prior to the proposed start of said activity. The approval or rejection shall be in writing and shall state the condition of approval, if any, or the reasons for rejection.
- D. Failure to rule on the application in the designated time shall constitute approval of the variance.
- E. The Council or its designated representative may impose reasonable conditions on the granting of any variance within its sole discretion.

§ 1-6. Hindering compliance-Prohibited.

- A. No person shall hinder or interfere with by force or otherwise, the performance by any duly authorized agent or employee of the Town of South Windsor of any duty to comply with or enforce the provisions of this Chapter.
- B. No person shall allow on any property or premises owned or leased by him any activity that violates or fails to comply with this Chapter, or the terms or conditions of any permit, variance or order issued pursuant to this Chapter.

§ 1-7. Penalties for offenses.

The first violation of any of the provisions of this chapter shall be punished by a fine not to exceed \$100. Each day any such violation shall continue or each act in violation of this Chapter shall constitute a separate offense. The second violation by any person or entity of any provision of this chapter shall be punished by a fine of \$175. Subsequent violations of any provision of this chapter shall be punished by a fine of \$250.

§ 1-8. Enforcement.

- A. Any person aggrieved by any act constituting a violation of this Chapter may complain to the South Windsor Police Department and/or South Windsor Zoning Department staff, either or both of which shall enforce these provisions.
- B. The South Windsor Police Department and/or Zoning Department staff also is authorized to enforce this Chapter without any such complaint.
- C. This Chapter shall be enforced by citations issued by the designated municipal officers or employees.
- D. A citation hearing procedure is hereby established pursuant to C.G.S. Sec. 175c(a). The Town Manager shall appoint one or more citation hearing officers, other than police officers or employees or persons who issue citations, to conduct the hearings authorized by this section. The citation hearing procedure provisions of C.G.S. Sec. 7-152c, subsections (c) through (g), inclusive, are hereby adopted and incorporated by reference as if fully set forth herein.

§ 1-9. Severability

All provisions of the Charter, Ordinances and/or Zoning Regulations of the Town of South Windsor, which are more stringent than those set forth herein, remain valid and may be enforced in addition to the provisions of this Chapter. If any section, paragraph, sentence, clause or phrase of this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid, or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portion of this ordinance or any part thereof.
