## 5. Communications and Reports from Town Manager

Mr. Michael Maniscalco, Town Manager, reported on the following items:

## 5. Communications and Reports from Town Manager (Continued)

- The Mestek Fuel Cell is completed but not on-line. The Town will look into when payments start.
- There is a State Statute related to tax abatements. There are perimeters set around the amount of the money the business is going to be investing in the renovation, expansion or moving into the Town of South Windsor. The first threshold is for \$500,000; once the business hits this amount, the Town can offer them a reduction in the amount of the estimated real property assessment of the Real Property by no more than 70% for three years. If the business is investing of over \$3,000,000, the Town can then offer them a reduction in the amount of the estimated real property assessment of the Real Property by 70% for seven years. For smaller businesses, making an investment of \$100,000 or more, the Town can do three years but for 50% or less.
- If the Town Council members would like to update their Strategic Plan, it is felt that this process could be done in-house rather than hiring a facilitator.
- A court date has been scheduled for 460 Miller Road on Thursday, December 19, 2019.
- Recognized and thanked the Department of Public Works for their hard work during the current winter storm.

Answering questions from the Council, Mr. Maniscalco explained that the threshold for a tax abatement is \$100,000 for three years at 50% but will do more research to see if there is anything further for small businesses. Most tax abatements are given for larger corporations that are moving.

LL. Discussion Item: Update on the Laurel Street Traffic Study (requested by Town Manager Michael Maniscalco) (Jeff Doolittle, Town Engineer to be present)

Mr. Jeff Doolittle, Town Engineer, explained that the Council members should have received the first twelve pages of the Traffic Calming Study done on the Laurel Street neighborhood. The whole report consists of 133 pages with the first twelve pages containing the summary and recommendation, and the remaining pages containing the data reports and traffic counts. The consultant set up counters in thirteen locations and camera counters at two intersections in the Laurel Street neighborhood. Mr. Doolittle reviewed the data that the consultant collected and explained that the consultant has recommended, if anything, to do minor traffic calming on Woodland Street by reducing the lane widths to slow down vehicles and to do more speed enforcement. This would be accomplished by having fog lines placed on the road. There will be a public information meeting held on Wednesday, December 11, 2019. Everyone in the neighborhood has been notified about the meeting, and an announcement will be put on the Town's website.

Councilor Snyder stated she would like to see the lines placed on the road as soon as possible. This is a pilot for the policy and is critical, not only for the neighborhood but to the Council because there is a safety issue.

Answering further questions, Mr. Doolittle explained that the defined criteria in the policy were established by reviewing other policies created by other Towns, as well as guidance through the State and Federal Highway Administration. It was determined that traffic calming measures would be best suited on Woodland Drive because Woodland Drive met three out of the five criteria. It is felt that calming the traffic on Woodland Drive will help calm traffic throughout the whole neighborhood.

Mr. Doolittle informed the Council that since the Traffic Calming Policy was adopted, the Town has not received any formal requests or complaints.

Mayor Paterna stated that a traffic count of 486 cars driving through a neighborhood with 50% of those vehicles using the road as a cut-through is a lot of vehicles and he does not understand why it would not be suggested to try to eliminate some of the traffic with traffic calming measures that are relatively inexpensive. Mr. Doolittle explained that there would be an opportunity to explore more options at the public informational meeting, but according to the study, only Woodland Street met the criteria in terms of the traffic volume. Other options such as putting lines on the major roads in the neighborhood and fog lines on Woodland and Oak Street will narrow the lanes for traffic, and it will also provide pedestrians some space to walk.

Mayor Pater then stated that options need to be explored because the best techniques found can then be used throughout the Town when other neighborhoods come in with a complaint.

Answering questions from the Council, Mr. Maniscalco explained that the Commission is appointed by the Town Council, who also determines the number of members (between 5-15) and shall consist of no more than 1/3 from the elected or appointed Town office holder and no more than a bare majority from any one party. If there were a Commission established with five members, there would be two Republicans and three Democrats. If an unaffiliated voter were on the Commission, there would be two Democrats, two Republicans, and one unaffiliated member.

Mayor Paterna stated that there would be a resolution at the next Town Council Meeting to decide whether to move forward with the creation of a Charter Revision Commission.

# QQ. Discussion Item: Review Draft Debt Policy, Deficit Mitigation Policy, and General Fund Policy (requested by Town Manager Michael Maniscalco)

Mr. Maniscalco informed the Council that they received three policies for their review. These policies are presented to the Rating Agencies when the Town is having its rating reviewed. The Town currently has a Debt Policy and General Fund Policy in place, but these policies have been updated to make sure they are consistent with current practices. The Deficit Mitigation Policy is a new policy and has been drafted as a disaster scenario, such as if the State of Connecticut decided to cut all of the Town's ECS Funding or something of that nature. This policy outlines different options the Town has that could potentially be used to offset the deficit.

Answering questions, Mr. Maniscalco stated that he would like to have a resolution at the next meeting to approve all three of these policies. If any Council member would like to see any changes to these policies, Mr. Maniscalco requested Council members call him to discuss the change. There may be more financial policies for the Council to review in the future.

Mr. Maniscalco explained to the Council that these policies were reviewed and updated by the Finance Director and the Financial Advisor. One of the largest updates was to the Debt Policy. At the end of the policy, there was standard language related to debt management and disclosure added. The updates were determined by reviewing our current practices to make sure we are following policy and also using the standard language used by other communities. The Deficit Mitigation Policy is a policy that Mr. Maniscalco said he had the opportunity to put together in his last position. The loss of revenue from the State of Connecticut or other revenue sources is one of the biggest threats to a budget, and having a plan in place and options available are appreciated and looked upon favorably when the Town goes for a rating.

Councilor Evans requested that the Council get a copy of the policies showing all of the edits that were made.

## RR. Discussion Item: Creation of a Budget Policy Statement (requested by Mayor Paterna)

Mayor Paterna suggested that Councilor Snyder and he get together and work on a draft Budget Policy Statement and present it to the Council at the next Council Meeting. This would be a statement that gives some direction to Town staff and the Town Manager in terms of how to formulate the budget for next year.

## TT. Discussion Item: Broadcasting Board and Commission Meetings (requested by Mayor Paterna)

Mayor Paterna explained that this discussion is regarding potentially televising/broadcasting Board and Commission Meetings to promote open government. In order to promote open government, there are three overwriting principles which are participation, collaboration, and accessibility, as shown in attached **Exhibit B**. Mayor Paterna asked Mr. Scott Roberts, Assistant Town Manager, if this could be done?

Mr. Scott Roberts, Assistant Town Manager, explained that currently, the Council Chambers is the only studio that the Town has consisting of three cameras that are controlled from a room downstairs. That information is fed out to a channel for dissemination of public information. This could be done to additional meeting rooms at the Town Hall but would cost approximately \$15,000 per meeting room. There are two other options that the Council can review as follows:

- The Administrative staff could set up a hand held camcorder, which would not cost anything.
- Mount cameras in the other meeting rooms to record to a DVR, which would cost \$5,000 to \$7,000 to do two meeting rooms.

Both options would not be a live stream. The second option is felt to be the simplest and most robust for recording of Town meetings.

Mayor Paterna suggested that Boards and Commission use the Council Chambers for their meetings.

Councilor Snyder agreed with Mayor Paterna's suggestions and stated that the Planning & Zoning Commission and Water Pollution Control Authority already meet in the Council Chambers for their public hearings.

Mr. Roberts also agreed that using the Council Chambers makes sense, but explained to the Council that this suggestion would cost money for the individual who would be downstairs recording the meetings.

Councilor Snyder felt that the Commissions that are being discussed to be video tapes are large Commissions, and there should be quality recordings for the public. Doing the recordings will allow the public to know what is happening in Town.

Mr. Roberts then explained that doing the recordings with the assistance of the IT staff requires the shifting of an employee's hours, and if this is done for multiple Commissions, the IT Department will lose the time of an employee during the day to help with regular IT initiatives.

#### AMENDS ORDINANCE #224

## AN ORDINANCE AUTHORIZING THE ACQUISITION OF OPEN SPACE/PURCHASE OF DEVELOPMENT RIGHTS

Pursuant to the November 8, 2005 Resolution Appropriating Funds For Acquisition of Open Space and consistent with the Town's Plan of Conservation and Development and its Open Space Master Plan, the Town shall acquire and hold as open space the real properties identified below. The properties shall be acquired in accordance with the Town's Charter and Code of Ordinances and the General Statutes regarding the acquisition of real property and open space, and pursuant to the terms of any purchase and sale agreement and costs and expenses approved therefor by the Town Council. Consistent herewith, the Town Manager is authorized to enter into any Town Council approved purchase and sale agreement and to execute all documents necessary to facilitate the acquisition of the real properties identified below.

- 1. 491 King Street, South Windsor, Connecticut
- 2. 559 Avery Street, South Windsor, Connecticut
- 3. R002A Collins Lane, South Windsor, Connecticut (corner of Sand Hill Road and Nevers Road)
- 4. 1355 Ellington Road, South Windsor, Connecticut

## and/or Development Rights:

1. R043, R044, 726, and R048 Main Street, South Windsor, Connecticut; and R011 Pleasant Valley Road, South Windsor, Connecticut

1. \*OPEN GOVERNMENT INITIATIVE: Televising/Broadcasting specific Commission meetings (w/Documents online).

This would include: Planning & Zoning Commission; Park & Recreation Commission; Economic Development Commission; Open Space Task Force; Water Pollution Control Authority; Energy Committee—as the first group in this transition!

\* The South Windsor OPEN GOVERNMENT INITIATIVE:
