The following are motions made during the September 1, 2016 Public Hearing/Regular Meeting.

Chairperson Dickey-Gaignat called the public hearing to order at 7:30 pm in the Madden Room.

The Recording Secretary read the legal notice as published in the Journal Inquirer.

1. Public Hearing

Appl. 2794-16 – Robert Mannarino c/o The Windsor Learning Center, Inc. - request for a 17.7 ft variance to Table 3.1.2A to allow the construction of a 2,800 sf single-story addition to the existing daycare facility, to be located 32.3 ft from the rear property line (50 ft required), on property located at 1250 Ellington Road, RR Zone.

Commissioner Carty stated for the record that his son had attended the Learning Center for a few years, approximately 2006-2009, and that he would be able to impartially review this application. He felt there was no conflict of interest.

Robert Mannarino, owner/applicant presented the application. Mr. Mannarino presented background information regarding the special exception approved by the Planning and Zoning Commission in 1997 to allow the daycare facility in a residential area. Mr. Mannarino stated that a variance would not be needed if this business was located in a commercial zone as the setback requirements would be different. The proposed plan would locate the addition at the back of the existing structure. There would be room for additional parking in the front, a safer drop off area for the children and be more aesthetically pleasing. Mr. Mannarino also stated that there is an alternative plan that would not require a variance. The addition would be attached to the front; restricting parking and not be as attractive. The proposed addition could be smaller but this would be the preferred size and would allow increased attendance at the day care. The playground would remain at the rear of the property but would have to be moved from its current location. Additional parking would also improve traffic flow when picking up and dropping off children.

Commissioner Carty read into the record two letters of support from abutting property owners for the proposed plan.
